FUND MANAGER COMMENTS

Annual inflation declined from 3.4% in February to 3.2% in March. The Manufacturing Purchasing Managers' Index fell from 50.3 in March to 49.1 in April. The Services Purchasing Managers' Index increased from 53.1 in March to 55.0 in April. Retail sales increased by 0.8% year-on-year in March. In markets, SONIA remained unchanged at 5.19%, the 2-year gilt yield rose from 4.16% to 4.42% and the 5-year gilt yield increased from 3.82% to 4.18%. We bought UK Treasury bills. While the inflation outlook appears positive and investors are pricing in no further rate hikes, selective term investments were favoured. Positioning will be determined by upcoming central bank meetings. The weighted average maturity of the Fund was 26 days at the end of March and 23 days at the of April.




