FUND MANAGER COMMENTS

The Fund generated a positive return in March. Risk free assets were volatile, but credit spreads tightened. The Fund's long credit positioning was positive given spread tightening. Our long positions in loans and asset-backed securities contributed. Our relative value credit positions were also positive, as the outperformance of credit default swaps relative to physical credit partially reversed. Country selection proved beneficial, owing to our short position in Canada relative to Australia and New Zealand. The Fund's duration positioning was neutral, as government bond yields were broadly unchanged. We took profit from our long position in the US. Inflation positions were positive. Yield curve positioning was neutral, as our steepener position in the US was offset by a flattener position in the UK. Our emerging market positions were neutral. Finally, the Fund's currency positioning was positive, as the short position in the Swiss franc contributed to performance.

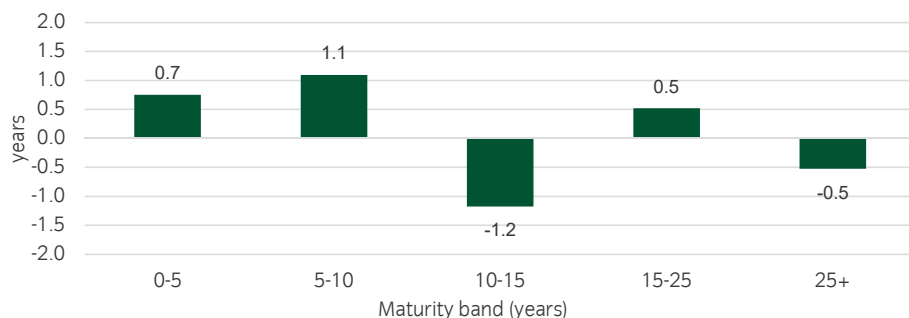

DURATION EXPOSURE BY MATURITY

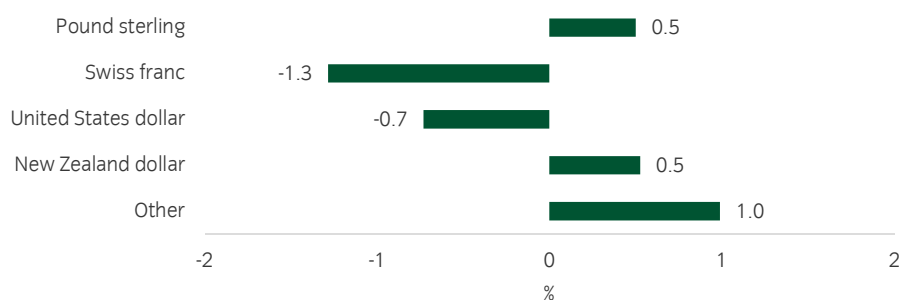
