
FUND MANAGER COMMENTS

The Fund generated a positive return in July. Risk free assets posted gains, while investment grade credit spreads tightened. The Fund's long credit positioning was a positive. Our long positions in loans and asset-backed securities also contributed. Our relative value credit positions were neutral. European investment grade credit outperformed its US counterpart, but credit default swaps outperformed cash and credit. Country selection proved beneficial, driven by our long position in Italy versus France. We increased our position in Sweden versus Europe. The Fund's duration positioning added value, due to our long position in US Treasuries and 5-year German bunds. The Fund's inflation positioning contributed to performance. Yield curve positioning was a positive, as our steepener positions in the US and Germany worked well. Our emerging market positions had a neutral effect. Currency positioning detracted, due to our long position in the Norwegian krone and short position in the yen.
