FUND MANAGER COMMENTS

Annual inflation declined to 3.4% in February. The Bank of England maintained its base rate at 5.25%. Meanwhile, a final reading confirmed that UK GDP contracted by 0.3% in the last quarter of 2023, meaning that there was a technical recession. The Manufacturing Purchasing Managers' Index rose from 47.5 in February to 50.3 in March. In markets, SONIA remained unchanged at 5.19%, the 2-year gilt yield declined from 4.28% to 4.16% and the 5-year gilt yield decreased from 4.04% to 3.82%. While the inflation outlook appears positive and investors are pricing in no further rate hikes, selective term investments were favoured. Positioning will be determined by upcoming central bank meetings. The weighted average maturity of the Fund was 23 days at the end of February and 26 days at the end of March.




