FUND OBJECTIVE

The Fund seeks to maintain the principal of the Fund and to provide shareholders with daily liquidity with an income which is comparable to sterling denominated short dated money market interest rates

- Daily liquidity with one day's notice
- Aims to add value with money market instruments collateralised by UK gilts, with counterparties including PPF eligible pension schemes as well as banks

FUND MANAGER COMMENTS

Data in June has increased the likelihood of an interest rate cut. Annual inflation declined from 2.3% in April to 2.0% in May, meeting the Bank of England's (BoE) target, while the Manufacturing Purchasing Managers' Index declined from 51.2 in May to 50.9 in June. The BoE left its Bank Rate unchanged at 5.25%, but markets speculate an August cut is likely. In markets, SONIA remained unchanged at 5.20%, the 2-year gilt yield declined from 4.41% to 4.22% and the 5-year gilt yield declined from 4.22% to 4.02%. While the inflation outlook appears positive, selective term investments were favoured. Positioning will be determined by central bank meetings. The weighted average maturity of the Fund was 19 days at the end of May and 21 days at the end of June.

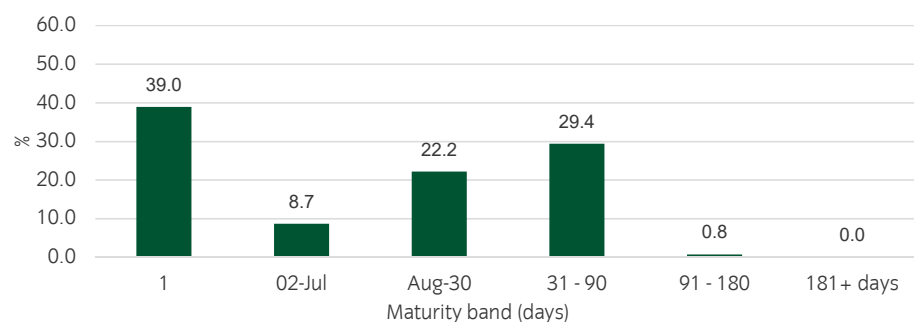

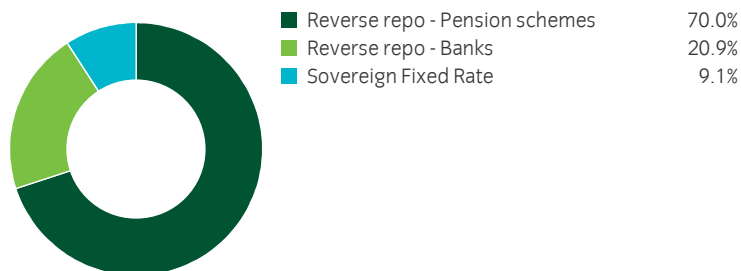
