FUND MANAGER COMMENTS

The UK saw largely positive economic signals in July. Annual inflation was unchanged at 2.0% in June. The Manufacturing Purchasing Managers' Index rose from 50.9 in June to 52.1 in July. The Services Purchasing Managers' Index edged up from 52.1 in June to 52.4 in July. The unemployment rate was unchanged at 4.4% in the three months to May. In markets, SONIA remained unchanged at 5.20%, the 2-year gilt yield fell from 4.22% to 3.70% and the 5-year gilt yield declined from 4.02% to 3.67%. While the inflation outlook appears positive, selective term investments were favoured, alongside earning interest on secured short-term loans through reverse repos. Positioning is determined by central bank meetings. The weighted average maturity of the Fund was 21 days at the end of June and 20 days at the end of July.




