The Fund seeks to maintain the principal of the Fund and to provide shareholders with daily liquidity with an income which is comparable to sterling denominated short dated money market interest rates

- Daily liquidity with one day's notice
- Aims to add value with money market instruments collateralised by UK gilts, with counterparties including PPF eligible pension schemes as well as banks

FUND MANAGER COMMENTS

The Bank of England cut the Bank Rate in August for the first time since 2020, reducing it by 25bp to 5%. Annual inflation rose by 20bp to 2.2% in July, as the declines in gas and electricity price moderated. The economy expanded by 0.6% in the second quarter according to a preliminary estimate, marginally lower than the 0.7% growth rate recorded in the previous quarter. The Manufacturing Purchasing Managers' Index rose from 52.1 in July to 52.5 in August. In markets, SONIA fell from 5.20% to 4.95%, the 2-year gilt yield rose from 3.70% to 3.72% and the 5-year gilt yield increased from 3.67% to 3.92%. While the inflation outlook appears positive, selective term investments were favoured. Positioning will be determined by central bank meetings. The weighted average maturity of the Fund was 20 days at the end of July and 25 days at the end of August.

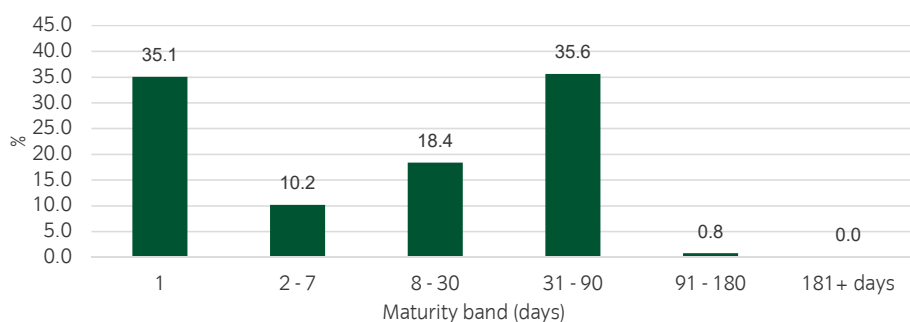

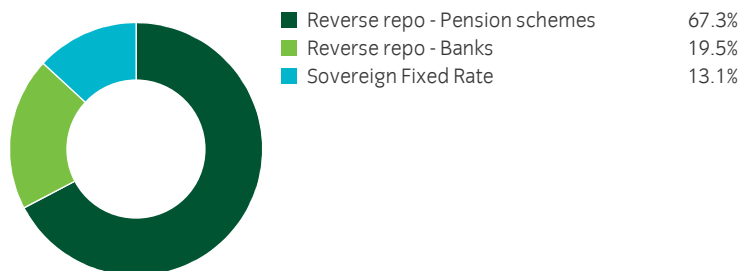
