The Fund seeks to maintain the principal of the Fund and to provide shareholders with daily liquidity with an income which is comparable to sterling denominated short dated money market interest rates

- Daily liquidity with one day's notice
- Aims to add value with money market instruments collateralised by UK gilts, with counterparties including PPF eligible pension schemes as well as banks

FUND MANAGER COMMENTS

The one piece of key positive economic news in November was the Bank of England cutting interest rates by 25bp to 4.75%. Otherwise, the UK economy expanded by only 0.1% in the third quarter, down from a growth rate of 0.5% in Q2, while the Manufacturing Purchasing Managers' Index declined from 49.9 in October to a nine-month low of 48.0 in November. Annual inflation rose by 60bp to 2.3% in October. In markets, SONIA fell from 4.95% to 4.70%, the 2-year gilt yield declined from 4.36% to 4.24% and the 5-year gilt yield decreased from 4.31% to 4.09%. While the inflation outlook appears positive, selective term investments were favoured. Positioning will be determined by central bank meetings. The weighted average maturity of the Fund was 22 days at the end of October and 28 days at the end of November.

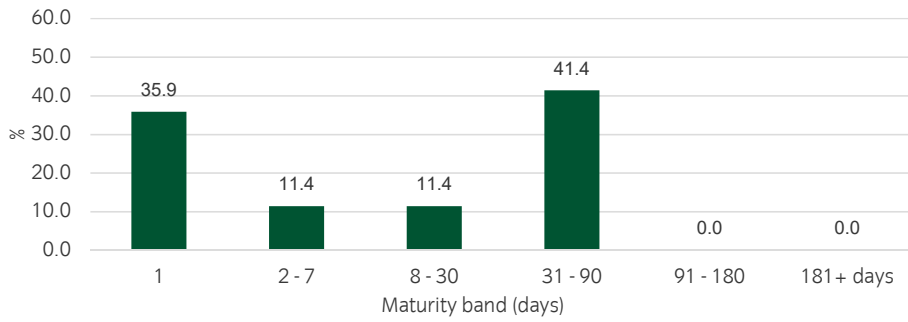

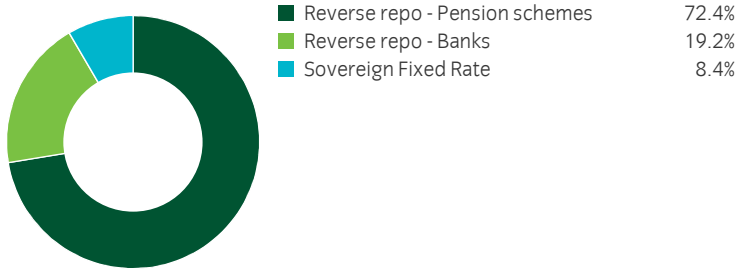
