
FUND MANAGER COMMENTS

The Fund had another strong month and outperformed the cash benchmark. In March, investors priced fewer interest rate cuts in 2024. Leveraged loans posted gains for the fifth consecutive month but underperformed high yield bonds. Over the month, key contributors included Term Loan B financings from Valeo Foods, Motor Fuel Group and T-Mobile Netherlands. The European default ratio decreased from 1.9% to 1.6%, while the distress ratio fell marginally from 2.76% to 2.74%. Over the month, European loan volumes fell. Refinancing comprised more than half of the activity. We expect defaults to reach around 3% in 2024. We continue to focus on companies with strong cash flow and believe that skilful security selection will help investors collect the entire coupon, while avoiding defaults. Leveraged loans are still supported by strong technicals, limited supply and strong investor inflows.


