## FUND MANAGER COMMENTS

The Fund continued to perform well, increasing its year-to-date outperformance of the cash benchmark. In April, investors priced in the prospect of rates remaining higher for longer. Leveraged loans posted gains for the sixth consecutive month and outperformed other assets. Key contributors over the month included Term Loan B financings from Motor Fuel Group, Univar Solutions, T-Mobile Netherlands, Parts Holding Europe and MasMovil. The European default ratio decreased slightly from 1.6% to 1.5%, while the distress ratio fell from 2.74% to 2.51%. European loan volumes fell during the month, with refinancing comprising 43% of activity. We expect the default ratio to reach around 3.25% in 2024. We continue to focus on companies with strong cash flows and believe that skilful stock selection will help investors collect the entire coupon while avoiding defaults. Leveraged loans are still supported by strong technicals, limited supply, and strong investor inflows.

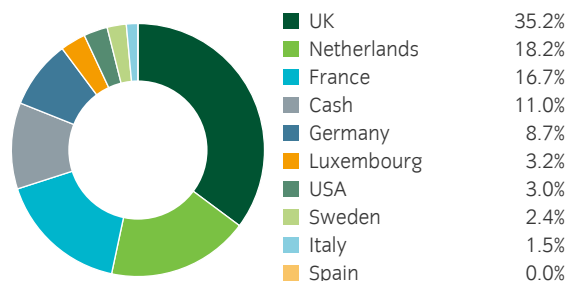

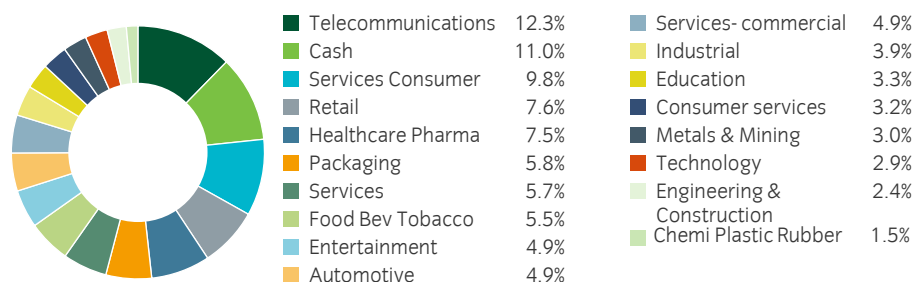

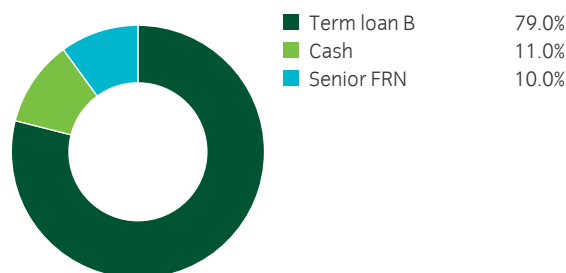
## GEOGRAPHY
