

FUND MANAGER COMMENTS

The Fund outperformed its cash benchmark in May. Risk assets posted gains as commentary from the US Federal Reserve was less hawkish. European structured credit performed well, owing to a combination of carry and broad-based spread tightening. Despite historically elevated valuations, relative value versus corporate credit remains attractive. The best performers remain in the bottom part of the investment grade tranche of the capital structure, due to strong investor demand. The month saw the largest issuance since the Global Financial Crisis. Supply across jurisdictions, sectors and ratings was absorbed, as deals were heavily oversubscribed. US structured credit saw elevated issuance and strong demand. BBB- and BB-rated assets outperformed their peers, with tightening across on-therun and esoteric sectors. May was quiet on the new lending side. Performance was driven by carry as well as the outperformance of collateralised loan obligations and commercial mortgage-backed securities.




