#### **FUND MANAGER COMMENTS**

The UK saw largely positive economic signals in July. Annual inflation was unchanged at 2.0% in June. The Manufacturing Purchasing Managers' Index rose from 50.9 in June to 52.1 in July. The Services Purchasing Managers' Index edged up from 52.1 in June to 52.4 in July. The unemployment rate was unchanged at 4.4% in the three months to May. In markets, SONIA remained unchanged at 5.20%, the 2-year gilt yield fell from 4.22% to 3.70% and the 5-year gilt yield declined from 4.02% to 3.67%. We bought certificates of deposit and commercial paper from First Abu Dhabi Bank, Nordea, Svenska Handelsbanken, National Australia Bank, Santander, BNG and Barclays. We bought floating rate notes from Commonwealth Bank of Australia and bonds from NRW.BANK and Kommunalbanken. The weighted average maturity of the Fund was 37 days in June and 40 days in July.




