FUND MANAGER COMMENTS

The day after it was announced annual inflation rose by 30bp to 2.6% in November, the Bank of England left its base rate unchanged at 4.75%. This rise in inflation was accompanied by stagnant growth; it was reported that the UK economy did not grow in the third quarter compared with a growth rate of 0.4% in Q2. The Manufacturing Purchasing Managers' Index declined from 48.0 in November to an 11-month low of 47.0 in December. In markets, SONIA remained at 4.70%, the 2-year gilt yield rose 4.24% to 4.39% and the 5-year gilt yield increased from 4.31% to 4.34%. We bought certificates of deposit and commercial paper from ADCB, Goldman Sachs and Royal Bank of Canada. We bought bonds and floating-rate notes from ANZ.

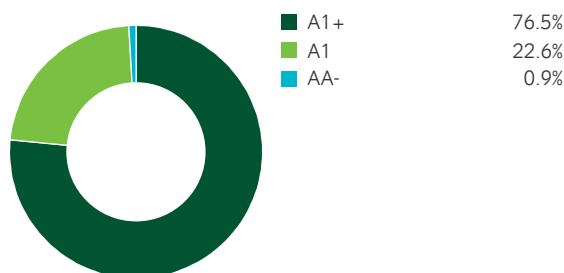

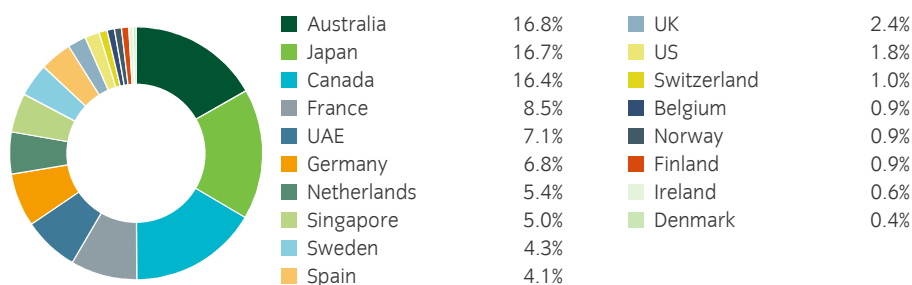

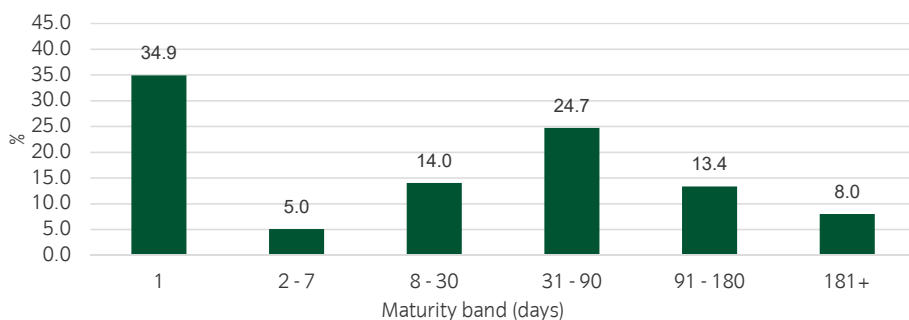

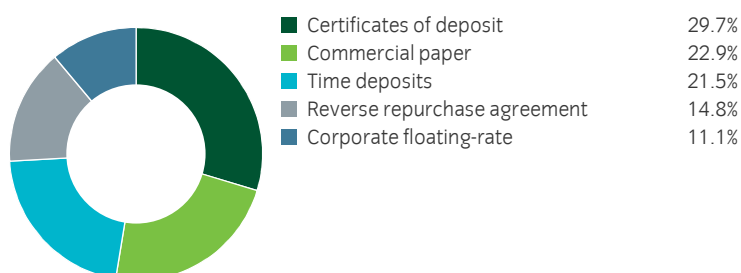
GEOGRAPHY
