FUND MANAGER COMMENTS

The Bank of England cut the Bank Rate by 25bp to 4.5% on 6 February in recognition of "substantial" progress in limiting inflation over the past two years. However, later in the month it was revealed that annual inflation rose to 3.0% in January up from 2.5% in December. A preliminary estimate showed that the economy expanded by 0.1% in the fourth quarter of 2024. However, the Manufacturing Purchasing Managers' Index declined from 48.3 in January to 46.9 in February. In markets, SONIA fell from 4.70% to 4.45%, the 2-year gilt yield declined from 4.24% to 4.19% and the 5-year gilt yield decreased marginally from 4.21% to 4.20%. We bought certificates of deposit and commercial paper from Abu Dhabi Commercial Bank, Commerzbank, GSIB, Bank of Tokyo, BFCM and BPCE. We bought bonds and floating-rate notes from OCBC, Royal Bank of Canada, ANZ and ABN Amro and an asset backed security securitisation from Elvet.




