## FUND MANAGER COMMENTS

In a dramatic move, the US Federal Reserve made its first fed funds rate cut in four years a 50bps cut to 4.75%–5.00% when a 25bp cut had been long predicted. This followed the news that US annual consumer price inflation had declined from 2.9% in July to 2.5% in August. The economy expanded at an annualised growth rate of 3.0% in the second quarter, according to a final reading, however the Manufacturing Purchasing Managers' Index declined from 47.9 in August to 47.3 in September. The unemployment rate edged lower by 10 basis points to 4.2% in August. In markets, the Secured Overnight Financing Rate fell from 5.33% to 4.96%. While the inflation outlook appears positive, selective term investments were favoured. Positioning will be determined by central bank meetings. The weighted average maturity of the Fund was 13 days at the end of August and 15 days at the end of September.

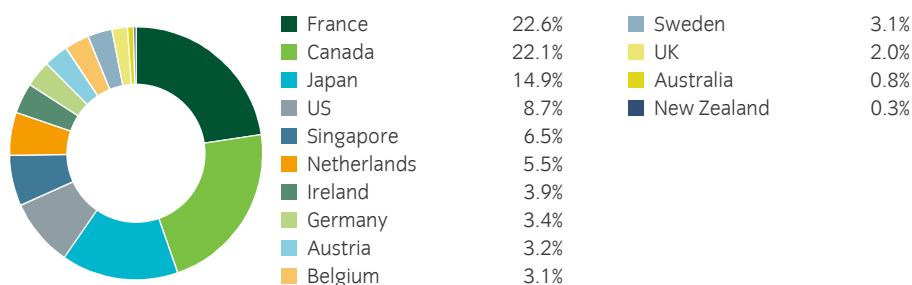

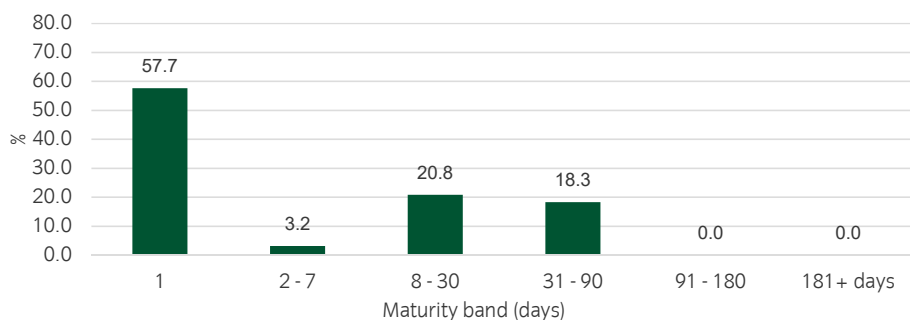

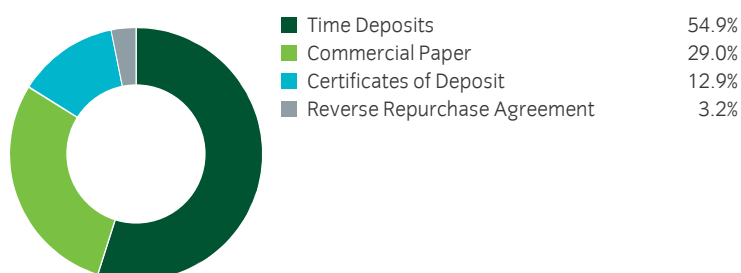
