#### **FUND MANAGER COMMENTS**

There were overwhelmingly strong data reports for the US in October. Annual inflation declined by 10bp to 2.4% in September. The economy expanded at an annualised growth rate of 2.8% in the third quarter. The Manufacturing Purchasing Managers' Index rose from 47.3 in September to 48.5 in October. The unemployment rate edged lower by 10bp to 4.1% in September. In markets, the Secured Overnight Financing Rate fell from 4.96% to 4.90%. While the inflation outlook appears positive, selective term investments were favoured. We bought floating rate notes from ANZ, DNB, NAB, RBC, Svenska, Westpac and UBS. Positioning will be determined by central bank meetings. The weighted average maturity of the Fund was 15 days at the end of September and 11 days at the end of October.






