FUND MANAGER COMMENTS

Annual inflation rose by 20bp to 2.6% in October. Despite the increase, the US Federal Reserve cut the target range for the federal funds rate by 25bp to 4.50–4.75% in November. A second estimate released during the month confirmed that the US economy grew at an annualised rate of 2.8% in the third quarter. The Manufacturing Purchasing Managers' Index rose from 48.5 in October to 49.7 in November. In markets, the Secured Overnight Financing Rate fell from 4.90% to 4.59%. We bought certificates of deposit and commercial paper from Deka and Republic of Finland. We bought bonds and floating-rate notes from the Royal Bank of Canada. While the inflation outlook appears positive, selective term investments were favoured. Positioning will be determined by central bank meetings. The weighted average maturity of the Fund was 11 days at the end of October and 20 days at the end of November.

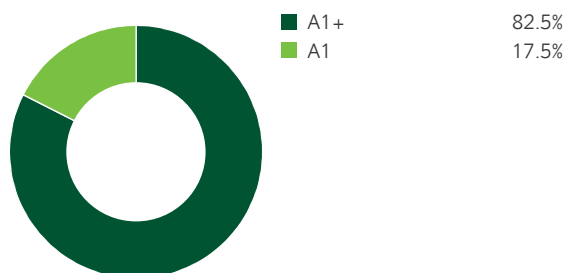

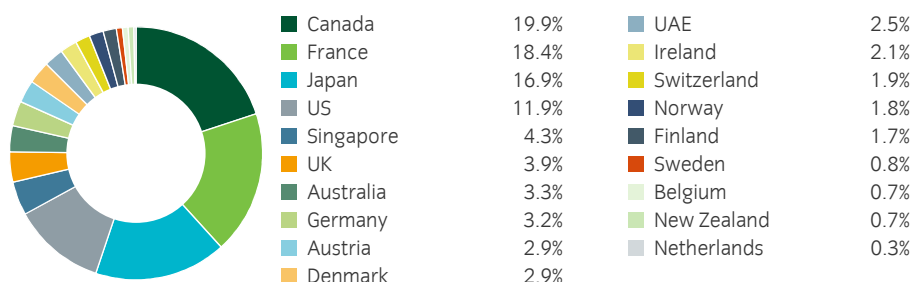

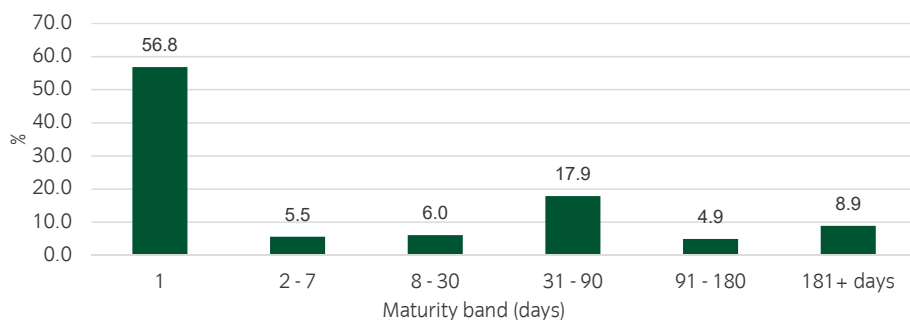

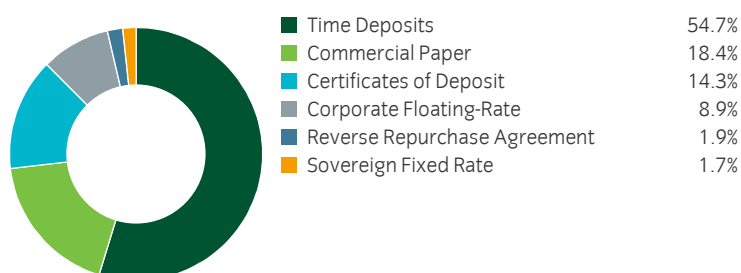
GEOGRAPHY
