FUND MANAGER COMMENTS

The US Federal Reserve cut the target range for the federal funds rate by 25bp to 4.25–4.50% in December despite a 10bp rise in annual inflation rose to 2.7% in November. Alongside this the US economy grew at an annualised rate of 3.1% in the third quarter according to a final reading. However, the Manufacturing Purchasing Managers' Index fell slightly from 49.7 in November to 49.4 in December and the unemployment rate rose by 10bp to 4.2% in November. In markets, the Secured Overnight Financing Rate fell from 4.59% to 4.49%. While the inflation outlook appears positive, selective term investments were favoured. Positioning will be determined by central bank meetings.




