FUND MANAGER COMMENTS

The US Federal Reserve left the target range for the federal funds rate unchanged at 4.25–4.50% in January despite a 20bp rise in annual inflation from 2.7% in November to 2.9% in December. Alongside this, the US economy grew at an annualised rate of 2.3% in the final quarter of 2024, according to a preliminary reading. The Manufacturing Purchasing Managers' Index increased from 49.4 in December to 51.2 in January. The unemployment rate declined by 10bp from 4.2% in November to 4.1% in December. In markets, the Secured Overnight Financing Rate fell from 4.49% to 4.38%. We bought bonds and floating-rate notes from CBA. Positioning will be determined by central bank meetings.

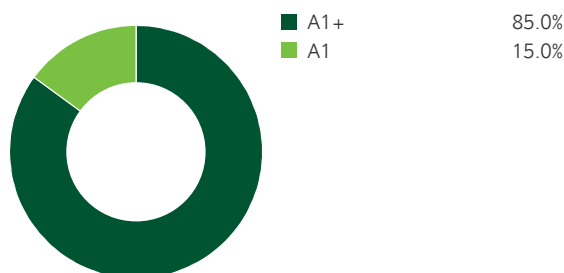

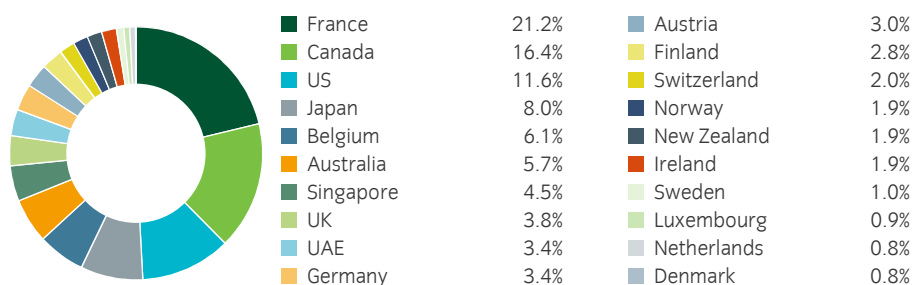

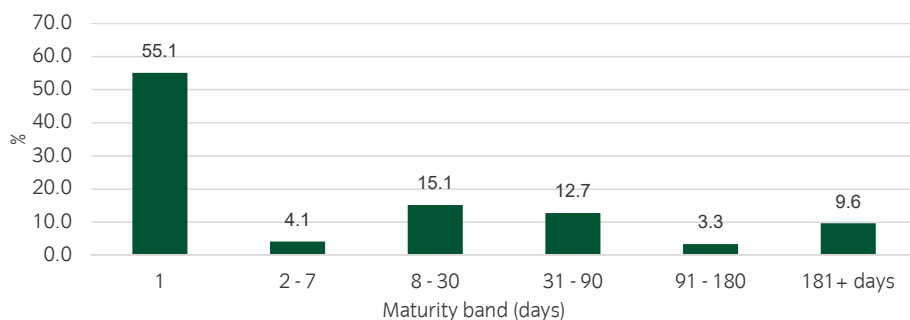

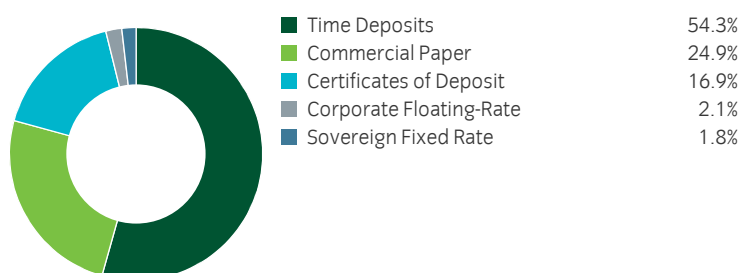
GEOGRAPHY
