#### FUND MANAGER COMMENTS

The Fund outperformed its cash benchmark in October, ending with a running yield of 126 bp over SONIA and a weighted average rating of AA. Risk assets sold off and bond yields rose, against strong economic data, persistent inflation, political uncertainty and geopolitical tensions. In contrast, European structured credit had a strong month, largely due to broadbased spread tightening, as investors took advantage of its high credit quality and short duration. US structured credit saw the most elevated monthly supply in over a decade. Demand was driven by attractive yields and record annuity growth. AAA- and BBB-rated credit spreads tightened, despite robust new issuance and secondary activity. In October, the Fund's purchases were tilted towards AA-rated positions and a blend of junior AAA- and AA-rated tranches in Australia. We rotated out of UK and Dutch residential mortgage-backed securities on tight valuations. During the month, performance was driven by carry.




